Terms and conditions and GDPR

Terms and Conditions for the Central European Jamboree 2024

I have read and agree to the Central European Jamboree 2024 Terms and Conditions and that in the event of any breach of these Terms and Conditions, I may be excluded from the event without refund.

General Rules

The Central European Jamboree 2024 is governed by the laws of the Slovak Republic.

- Rules and regulations which as set out by Scouting Slovakia and other national scout associations are to be respected at all times.
- The participants are obliged to follow the rules of conduct in the area (Camp Rules), which will be issued on site by the organizer of the event.
- Scouting Slovakia (Slovennský skauting, o. z.) reserves the right to modify these Terms and Conditions if there are significant changes in the organization of the event.

Registration guidelines

- Young people aged between 14 and 17 years (i.e. those born on and after the 2nd of August 2006 and no later than the 9th of August 2010) are eligible to take part in the Central European Jamboree 2024 as patrol participants.
- Individuals aged 18 and above (those born before 2nd of August 2006) wishing to take part in the Central European Jamboree 2024 can register to be members of the International Service Team (ISTs), Patrol Leaders (PLs) or Members of Contingent Management Team (CMTs).
- Patrol participants are registered in patrols of 10 persons (9 patrol participants and 1 Patrol Leader). IST registration is done individually.
- Patrol leaders that accompany patrols have a duty of care and as such are responsible for the behavior, safety and wellbeing of the patrol participants.
- Contingent is defined as an organizing unit for all Patrol participants, Patrol leaders, ISTs and CMTs coming from one National Scout Organization of Visegrad group (Czechia, Slovakia, Poland, Hungary). All participants must be members of their National Scout Organization, which is a member of WOSM or WAGGGS.
- Each Contingent is led by a Head of Contingent who is chosen by their National Scout Organization and they are responsible for the selection of the members of their Contingent.
- Each National Scout Organisation and Association/Member Organisation accept full responsibility for its members taking part in the Central European Jamboree 2024 and for ensuring that the adult participants are able to fulfill their duties.
- Adult participants from countries outside the Visegrad group can participate in the event only with the consent from Scouting Slovakia under the condition that they deliver the confirmation from their NSO that the participants are members of the NSO, which is a member of WOSM or WAGGGs, in good standing. The participation fee is the same as for the participants from Visegrad group countries and the participant must satisfy the conditions in these Terms and Conditions with the exception of the contingent-specific conditions.
- An exception to the Registration Guidelines can be given in special cases by Scouting Slovakia or the head of the event.

Participant Consents

- By completing the registration the participants agree to the terms of the GDPR, in its entirety here: <u>https://gdpr-info.eu/</u>.
- By registering personal information, such as name and date of birth, the individual explicitly consents to the retention of the personal data for purposes pertaining to the organisation and execution of the Central European Jamboree 2024.

Registration also implies explicit agreement with this Privacy Policy as well as with the Terms and Conditions of the Central European Jamboree 2024.

- Any personal information retained will not be shared with any third parties, except where necessary for the planning and execution of the Central European Jamboree 2024.
- By registering for the Central European Jamboree 2024, the participants consent to any media footage (e.g. video, photographs, audio) taken at the Central European Jamboree 2024, and in which they may feature, to be used by the Host Organisation (Scouting Slovakia), and as well as its licensees or assignees, for all advertising, publicity, and/or editorial purposes, for commercial and/or noncommercial purposes, for worldwide distribution in perpetuity.
- All participants (patrol participants, PLs, ISTs, CMTs, team members, staff members) and visitors must abide by the conditions of EU Digital COVID Certificate Regulation (Covidpass) during the entire duration of the event, and in addition the local conditions and limitations imposed by local authorities at their own expense.

Fees and insurance

- The patrol participants and PLs pay a fee of 250€. ISTs pay a fee of 150€. All fees are collected by the national contingents and then sent to the account of Scouting Slovakia. All fees must be sent before the date specified by the organiser of the event.
- The fee includes a place for a tent, the Central European Jamboree Programme including any relevant transportation during the event, excluding transport to and from the event itself, all meals for the duration of the Central European Jamboree from dinner on the 2nd of August 2024 through breakfast on the 9th of August 2024.
- It is recommended that the participants insure themselves with appropriate insurance cover, such as travel insurance for the period prior to arrival at the start of the Central European Jamboree and until after the finish of the event, together with the medical insurance. It is also recommended for the insurance to cover the alternative of cancellation of the event and any (medical or other) expenses related with Covid-19.

Cancellation conditions

- Upon payment of the participation fee, the registration becomes binding and any changes are subject to these cancellation conditions.
- Scouting Slovakia has the right to cancel the CEJ in its entirety, if a serious unforeseen circumstance occurs. These cases of serious unforeseen circumstances are considered to be, in particular, cases where such an unusual

circumstance makes the realisation of the CEJ

a) Not possible

b) Possible only with significantly increased safety, health, financial or legal risks associated with the realisation of the CEJ, or at the cost of a disproportionate increase in the financial or organisational costs of carrying out the CEJ. These are, in particular, cases of natural disaster, civil unrest, a significant increase in the risks associated with COVID or other epidemics, or measures taken by the relevant authorities, which significantly limit or hinder the planned course of the CEJ. The assessment of whether such circumstances have occurred will be made by Scouting Slovakia, after prior consultation with Heads of Contingent.

- Scouting Slovakia also has the right to cancel registration / participation only for some participants if there is a serious unforeseen circumstance that affects only these participants (e.g. government ban only for participants from a certain region).
- If Scouting Slovakia cancels the CEJ or cancels the registration / participation only for certain participants, affected participants will be refunded the amount equal to the proportional share of the budget balance after the payment of all the necessary expenses related to the preparation and/or cancellation of the event. This amount will be refunded within three months of cancellation.
- In case of a breach of the Terms and Conditions by a participant, that participant forfeits any right to a refund of the entry fee. If this violation causes the group in which the participant is registered no longer meets the registration requirements, the group can be also expelled from the event without any refund.
- If the registration is cancelled for any reason by the participant after the payment of the participation fee, the participant forfeits any right for a refund of the participation fee. However, upon communication with the Head of Registration, a change of participants in the group will be allowed and the participation fee can be transferred to the new participant. Even after this change, the group must comply with the Terms and Conditions.
- In case that a participant does not attend due to serious health issues, a maximum of 50 % of the participation fee will be refunded upon presentation of a medical report. A written medical report must be received by email registration@cej24.sk by the last day of the event. Change of participants in the group is possible.
- If the non-participation (cancellation, etc.) of one member means that the group no longer meets these Terms and Conditions, its registration can be considered invalid and can be terminated. The termination will be considered case by case based on the impact of this change on the patrol and the entire event. In case of termination the group is not entitled to any refund of the participation fee.

Personal Data Protection Information (GDPR)

Scouting Slovakia, the jamboree organisation use your personal data, in the following purposes:

- We will use the personal data of participants provided in the registration form (including information on special needs and the participant's diet) and data collected during the event and in connection with its course. We will use this personal data to: participate in the event, ensure the participant's safety and health during the event, including providing the participant with access to healthcare, storing the event documentation, in order to get in touch with parents or guardians on important matters regarding the participant (including to inform parents or guardians of an accident or illness of a participant). The legal basis for the use of the participant's personal data to ensure its safety and health is explicit consent (legal basis provided for in Article 9 (2a) of the GDPR). The legal basis for using the child is to protect the vital interests of the participant (legal basis provided for in Article 6 (1d) of the GDPR).
- In addition, we use the participant's personal data to defend against claims for damages against the person or property of the participant (legal basis provided for in Article 6 (1f) and Article 9 (2f) of the GDPR).
- In addition, we use the participant's image so that we can develop photographic documentation of various aspects of the event, as well as educational, informational and promotional materials and that we may disseminate these materials. The material will be stored for 10 years from the end of the event. The legal basis for perpetuating the child's image for this purpose is our legally legitimate interest (Article 6 (1f) of keeping records of Jamboree and its dissemination for this purpose your explicit consent (Article 6 (1a) of the GDPR).
- In relation with the Central European Jamboree 2024 Volunteers:
 - In order to implement the volunteer agreement concluded even only by spoken word between Scouting Slovakia and the volunteer; the legal basis for this data processing is necessity for the performance of a contract to which the data subject is party (Article 6 (1b) of the GDPRclaim); the data will be processed and stored for the period of the fulfilling of the agreement;
 - In order to perform statutory accounting obligations and obligations of the taxpayer of income tax from legal persons in the scope of proper documentation of tax deductible costs; the legal basis for processing of personal data is the legal obligation to which Scouting Slovakia is subject

(Article 6 (1c) of the GDPR); the data will be stored for 10 years from the end of the calendar year in which the tax payment deadline has expired;

- In order to introduce special supervision over the place of performing services by volunteers in the form of technical means enabling image registration (monitoring); the legal basis for this processing of personal data is the legitimate interest of Scouting Slovakia (Article 6 (1f) of the GDPR), consisting in ensuring the safety of persons, property protection and secret information, disclosure of which would harm Scouting Slovakia; this data will be stored for 3 months since the date of image registration;
- In order to develop photo documentation of various aspects of the event, as well as educational, informational and promotional materials and that we may distribute these materials. The legal basis for recording your facial image for this purpose is our legitimate interests (Article 6 (1f) of the GDPR), which consists of providing documentary of the Central European Jamboree 2024. The legal basis for distributing your facial image for this purpose is your explicit consent (Article 6 (1a) of the GDPR).
- We will disclose your personal data with the entitles cooperating with the event Organisation (Scouting Slovakia) in organising the Central European Jamboree 2024 under data entrustment agreements. The data will also be made available to offices providing accounting services to Scouting Slovakia, as well as to public authorities authorised to obtain such data in connection with the proceedings.

Rights of a data subject

Due to the fact, that Scouting Slovakia process your personal data, you have the right to:

- obtain from the controller confirmation as to whether or not your personal data is being processed, and, where that is the case, get access to your personal data and the relevant information related to the processing of your personal data (on the basis of Article 15 of GDPR);
- demand rectification of your personal data when it is inaccurate, incomplete or outdated;
- demand deletion of all or some of your personal data if: you have objected to the processing on the grounds of legitimate interests pursued by the controller, or your personal data is no longer necessary in relation to the purposes for which they were collected or have been unlawfully processed;
- demand restriction of processing your personal data (pursuant to Article 18 of GDPR) for the time necessary to decide on the legitimacy of your request to delete or certificate your personal data or for the time necessary for establishment, exercise or defence of your legal claims;

- object to processing of personal data on the basis of the legitimate interests pursued by the controller (Article 21 of GDPR); in such a case, Scouting Slovakia shall stop processing of your personal data in this purpose, and, if there is no other legal basis for the use of this data, we will remove it.
- You have also the right to withdraw your consent given to Scouting Slovakia to process your personal data, at any time. In order to do so, you shall contact Scouting Slovakia. The withdrawal of your consent does not entail any negative consequences, in particular, it cannot constitute a reason justifying refusal to conclude an agreement.
